Repository Observatory

COAR Repository Observatory is a new section of the COAR Newsletter. Its main goal is to identify trends and future scenarios in the

The COAR Repository Section will include: interviews with experts from different fields as to how they see the future panorama of repositories; links to innovative projects commenting about what changes and directions these projects bring to the repositories; presentations of innovative cases from COAR members institutions, as well as annotated bibliography of reports, articles, roadmaps, etc., with a visionary or strategic focus on the landscape of open access repositories

From the Working Groups

WG1: Repository Content

Working Group 1 is continuing to collect and post sustainable best practices for populating repositories on the COAR website <http://bit.ly/LyPF6r>. The Open Access Agreements and Licensing Task Force is in the information gathering stage and aims to have a preliminary report available in Autumn 2012.

WG2: Repository Interoperability

The “Repository Interoperability Roadmap” from Working Group 2 was successfully presented by the chair of Working Group 2, Eloy Rodrigues, in July 2012 in Edinburgh. Based on the first public draft version of the COAR Interoperability Roadmap (available since June 2012), this workshop presented an overview of the current and emerging services such as usage statistics, mass ingest processes, web standards compliance, maximizing web visibility, support for international and regional networks, and

integrating repositories into research administration workflows. Chair Eloy Rodrigues announced proudly that a final draft version of the COAR Current State of the Art Repository Interoperability document will be available in October. Eloy Rodrigues will present “Towards repository interoperability for Open Access and Open Science” session on 6 November as a Berlin 10 preconference event.

Open Repositories Conference

A workshop on the COAR Repository Interoperability Roadmap was hosted by Eloy Rodrigues on July 10 at the Open Repositories Conference in Edinburgh. COAR was one of the sponsors from the Open Repositories Conference. The conference brings together an international community of stakeholders engaged in the development, management, and application of digital repositories. Eloy presented the latest outcomes of the COAR interoperability project in order to help participants to make sense of the interoperability landscape, and to understand which standards and protocols support which services. Reports from the Regions

Latin America

A COAR poster was presented by Fernando Ardito, from the Universidad Peruana Cayetano Heredia, Peru, member of LA REFERENCIA, at the [15th International Symposium on Electronic Theses and Dissertations](#) (ETD 2012) held in Lima, Peru. At this conference, representatives from more than 30 countries from around the world shared key aspects of successful cases in the management of electronic theses and dissertations (ETDs) and knowledge of institutional repositories and open access software. Fernando Ardito reported many visitors to the COAR poster and a great interest in our activities.

Repository pilot experience:

Members of La Referencia Project recently evaluated the national conditions offered by those countries that are members of the aforementioned initiative, to start the Pilot Plan for the construction of a regional harvester.

During a meeting, held in Bogotá in August 27th and 28th, the participants worked to understand the National Nodes that will be connected to the Project's Repositories Network. Technical agreements and the strategic/political framework to advance the development of the Pilot Plan were also discussed and defined.

La Referencia Project expects the development and performance of a pilot project for a federated repository infrastructure- this will be in accordance with best practices identified

and the agreements achieved by the member countries

La Referencia presented the Diagnosis of Repositories in Latin America

The La Referencia Project looked at regional good practices for Open Access and Institutional Repositories. In a summation of this pilot, Lisowska emphasized the notable expansion of IR's in the region as a positive factor. However, she announced that "the diagnosis showed a worrying situation for the creation of regional networks: the lack of Repositories standardization, regarding metadata, the interoperability protocols and some other important aspects for building common services". This situation emphasises the importance of the La Referencia Project objectives and its search for consensus on these issues.

Asia

ICTK 2012 in Bangalore

Ikuko Tsuchide represented both the Digital Repository Federation (DRF) and Osaka University Library and presented COAR at the International Conference on Trends in Knowledge and Information Dynamics, 10-13 July 2012 in Bangalore, India. Norbert Lossau, who is a member of the international Programme Committee, as well as Alicia López Medina, were at the workshop, together with experts from India and Sri Lanka. North America

Repository at Cornell University

Oya Riegel from Cornell University, COAR member of North America is delighted to share the good news that the Simons Foundation will support arXiv's transition from an exclusive initiative of Cornell University Library (CUL) to a collaboratively governed, community-supported resource through a generous gift. arXiv has been based at Cornell University since 2001. The repository includes research in physics, mathematics, statistics, computer science and related disciplines. As an open-access service, it allows scientists to share “preprint” research before publication and boasts hundreds of thousands of contributors. In 2011 alone, arXiv saw close to 50 million downloads from all over the world and received more than 76,000 new submissions. “The sustainability planning process focused on how to diversify revenue models — but, equally importantly, we wanted to make sure arXiv could establish a set of governance principles. It’s setting an example of a transparent and reliable community-supported service,” said Oya Rieger, arXiv Program Director and Associate University Librarian for Digital Scholarship Services.
